Contract Round Up

During the year 2022 Fitzgerald have been busy on a wide range of highway and public realm schemes and a selection of these are featured below:

Inland Border Facilities Decommissioning, Birmingham Airport

Fitzgerald have been awarded a 16-week contract to carry out the decommissioning of temporary facilities at a HMRC managed car park to return it back to its original use as airport parking.

With a value of £2.3m the scheme on behalf of Speller Metcalfe was procured via the Crown Commercial Services Construction Framework. Site activities across an 12-acre area involves the removal of redundant infrastructure below ground and above ground including bollards, kerbing and re-surfacing.

Subsequently our team will install new ductwork, reinstatements to all areas, form raised footpaths and planted areas. We will fully resurface the whole car park (46,000m2) as well as carry out white lining for car parking spaces, installation of new external lighting and signage.

A457 Tollhouse Way Phase 2, Smethwick, West Midlands

The company are making excellent progress on a highway infrastructure scheme for Sandwell Council to construct a new cycling route. It includes the realignment of existing kerblines, new drainage, carriageway and footway surfacing, lining and signing.

Valued at £1.1m, the 22-week project was awarded through Fitzgerald's place on Lot 3 of the Black Country Framework for Minor Works. The main construction challenges are carrying out our works in a live environment adjacent to Rolfe Street railway station which has high pedestrian footfall.

Our team have worked extensively with Sandwell MBC, supply chain partners and stakeholders to develop robust traffic management and phasing plans to mitigate any disruption within the locality.

Smartparc Highway Infrastructure, Derby

We are currently delivering a £2m highway infrastructure scheme at SmartParc Spondon Campus in Derbyshire for new client TSL Ltd. Site works are taking place at two separate locations half a mile apart. The *A52 Raynesway* junction is being widened to increase network capacity to the existing dual carriageway on the approach to our main contract works at the *campus' northern access*. Our scope of works over the 22-week duration at the northern access involves realignment of the existing highway with enabling earthworks required for the construction of a new retaining wall with our works taking place alongside major statutory utilities diversions.

Section 278 Works - B4642 Coventry Road, Warwickshire

Fitzgerald are nearing completion of a highway upgrade scheme as part of Warwickshire County Council's Framework for the Provision of Engineering and Construction Works (Lot 1). The 13-week scheme in Rugby, with a contract value of £500k, consists of carriageway widening to form a new a right turn lane from Coventry Road into a new housing development for house builder Redrow Homes. The works are situated in a semi-rural environment and consist of the construction of a combined footpath and cycleway on the south side of Coventry Road, installation of kerbs, drainage, service diversions and ducting, road signs and road markings.

Evesham VeloPark, Worcestershire

Fitzgerald have successfully completed the delivery of a new state-of-the-art flagship VeloPark in Evesham for Wychavon District Council. Works on the £1.6m scheme involved constructing a 1km closed road circuit, a pump track, learn to ride track, an all-ability circuit aimed at supporting cycling for disabled riders, and a cyclo-cross course with unique mogul area. Fitzgerald were delighted to attend the exclusive opening event in October with representatives from British Cycling and BMX Champion Kye Forte taking to the tracks and giving a big thumbs up to the high-quality finish of the facility. The VeloPark is due to be officially unveiled to the public in December.
